



WHEREAS THE AUTHOR & FOUNDER OF THE TRUST being desirous of carrying out public, Social, Educational and Charitable activities to enable the deprived people to help themselves for Total Development.

AND WHEREAS it has now been decided that the work to be carried out should be brought under a Trust so that the work should be sustained and maintained on a regular basis.


AND WHEREAS for the aforesaid purpose the Author of the Trust has set apart a sum of Rs.1,000/- (Rupees One Thousand Only) from out of his own funds towards the CORPUS OF THE TRUST and has agreed that any further assets of movable or immovable nature to be acquired by the Trust either by gifts, contributions, donations or by accumulations thereto shall be used for the objects, intents and prescribed purposes hereinafter contained.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. NAME: The name of the Trust shall be: **OLIVE FOUNDATION**
2. REGISTERED OFFICE: The registered office of the Trust shall be. residing at No.16, Main Road, Thiruvalluvar Nagar, Chennai - 600 118
3. OBJECTS:
  - i) The main object of the Trust shall be to spread education by means of general, industrial, technical, vocational, engineering, medical, computer and business education by way of regular, residential, correspondence and distance education courses.
  - ii) To Carryout Development activities for the up-liftment of poor people.
  - iii) To prepare projects mainly intended for the women's welfare and physically handicapped.






- iv) To establish, maintain, run, acquire, improve, extend, upgrade or denote, aid and assist in the establishment, maintenance, running, development, improvement, and extension of Play School, Nursery & Primary Schools, Elementary, Middle, Secondary or Higher Secondary schools, science and polytechnics, Colleges of Engineering, Medicine, Business, Administration, Industrial Management, etc., and generally all kinds of Educational Institution whether general industrial, technical, vocational, professional and food craft through regular or correspondence or of other description whatsoever, to make the people academically fit in all their endeavours.
- v) To establish Training Centres, Model production centre and Industrial units to provide facilities/practical training to students of polytechnics or Engineering colleges and provide them adequate training and experience in production, financial, personal, marketing and Industrial management for providing entrepreneur skill to the outgoing students so as to install necessary confidence in their minds either to seek employment or to have self employment.
- vi) To accept gift or otherwise, lands, house sites and buildings, to erect, build and construct or to aid assist in the erection, construction of houses, buildings for educational institutions and libraries, staff quarters, hostels and/or other type of building or construction whatsoever and to maintain or run them and if necessary to alter, demolish or reconstruct them or any portion or portions thereof as may from time to time necessary or expedient.
- vii) To provide skill development programs, promote, economic and developmental activities and to organise program of vocational and technical training with a view to facilitating vertical mobility.
- viii) To establish, maintain, run or support institutions for youth welfare and HIV / AIDS patients.






- ix) To carry on relief work among urban street children to educate, to rehabilitate, to prevent and eliminate child labour.
- x) To open establish , promote, aid or help in the setting up and maintaining and running of hospitals, charitable dispensaries, maternity homes, child welfare centers, Old age homes, Balwadies, water rendering and providing medical relief to poor and needy people.
- xi) To create awareness among the people to teach the importance of education, immunization and environmental protection
- xii) To promote attitude/ideology about National integration and patriotism.
- xiii) To promote SHG and to guide them to function effectively.
- xiv) To promote the welfare of hill tribal from their stagnate condition.
- xv) To conduct adult education programs to eradicate illiteracy in the villages to acquire social awareness and over all development and providing training in handicrafts to create self-employment.
- xvi) To give, provide and render monetary and other helps and assistance for the relief of personnel and animals affected by natural and other calamities such as fire, flood, earthquake, and tsunami etc.
- xvii) To establish, maintain, run, promote, finance and to help in the setting up, maintaining and running up orphanages, homes for aged, destitute, physically and mentally Challenged and for the poor and down trodden.
- xviii) To establish Study centers and centers for Distance Education system of various universities.



- xix) To establish computer, tailoring courses for needed people to raise their life style and revenge.
- xx) To establish and maintain and endowments fund for providing scholarship loans, books and reading materials etc., to the students from weaker sections of the society.
- xxi) To enable to formulate and carryout common programmes and to support like minded organizations and individuals.
- xxii) To provide awareness regarding child health care, nutrition, environment, sanitation and legal support to women.
- xxiii) To undertake such other activities as may be necessary for the attainment of the objects of the trust and for the removal of doubts it is hereby declared that all objects of the trust shall be carried on without any profit motive which is beneficial to the trustees either directly or indirectly.
- xxiv) The above objects are independent of each other and the trustees may from time to time apply the funds of the trust in carrying out all or any one of the objects of the trust.
- xxv) To do all such things as may be necessary for the furtherance of the above objects of the trust, but shall not include activities for profit.
- xxvi) It is agreed that the income and contribution that to be acquired in future shall be spent towards the promotion of the Trust and any incidental work connected and no portion of it will be utilised for payment to Trustees by way of profit, interest, dividend etc.,
- xxvii) The activities of the Trust will not be carried out outside India.

xxviii) The Board have power to invest the funds of the trust at their discretion in accordance with the provisions of Section B713 (1) (d) read with Section 11(5) of the Income Tax, 1961.

xxix) This Trust shall be irrevocable.


xxx) It is declared that the benefits of the Trust shall be open to all irrespective of Caste, Creed, Colour, religion, community etc.

xxxi) In the event of dissolution of the trust, the entire trust funds shall be released and first be used for the payment of liabilities of the trust. The assets left, if any, shall be disbursed to other trust or association having similar object and which enjoys recognition under Section 80G of the Income Tax Act, 1961. And in no event it shall be appropriated either by the members or by any relative of the members of the trust.

xxxii) If any alteration or amendment are necessary the same shall be effected through supplementary deed with the previous approval of the commissioner of the Income Tax and it shall be read together with the main deed and it would not extent to altering the basic character/objects of the trust and further, no such amendments which may prove to be repugnant to the provisions of Section 2(15), 11,12 & 13 and 80G of the Income Tax Act, 1961 shall be made.


4. THE OBJECTS INCIDENTAL OR ANCILLIARY TO THE ABOVE MAIN OBJECTS ARE AS FOLLOWS:

1. To raise fund to support the aforementioned objects from within India and Abroad.
2. To solicit, receive, hold and disburse funds to promote the objects stated above and to hold funds and investments in trusts for the said objects.



3. To open and operated accounts of any description, with scheduled bank or banks for the Trust.
4. To appeal for and raise funds, subscriptions, grants and loans, as the Trustee may think fir.
5. To take on lease or acquire property by purchase or otherwise to promote the objects of the Trust.
6. To purchase, take on lease and license hire or otherwise acquire and to hold, manage administer and otherwise deal with any movable and immovable properties, rights and privileges as the Trustee Board may deem necessary, expedient or desirable for the promotion of any of the objects of the Trust.
7. To sell, alienate, lease give out on lease or license, mortgage charge, pledge, hypothecate, transfer, surrender, dispose of and or otherwise deal with all or any of the properties, funds and assets of the Trust without profit motive and only in the rarest occasions as the Board may feel/deem necessary, expedient or desirable for the promotion of the objects of the Trust.
8. To appoint agents or representatives or other workers on such conditions as may be thought fit by the Board of Trustees.
9. To enter into any contract or promoting any of the objects of the Trust, without profit motive.
10. The objects of the Trust shall be independent of each other. The Board of Trustees hereinafter constituted may from time to time, apply funds of the Trust in carrying out all or any of the objects of the Trust as it may in its absolute discretion, deem to be fit.
11. The Trust properties shall include all such future properties either movable or immovable that may be vested in the Board of Trustees and such other properties either movable or immovable that may hereafter gifted, or transferred to the Trust for the purposes of carrying out the objects of the Trust and all income derived from such properties, addition accretions and augmentations thereon.
12. To carry on such other objects as may be incidental to the promotion of any of the aforesaid objects or any other ancillary objects related to the main objects as may be considered fir by the trustee.

13. To get these institution recognised by the respective state Governments or affiliated to appropriate Boards of Education/Universities as the case may be and strive for excellence in academic standards.
14. To provide high quality education at very modest and reasonable rate /fees to the public in general and the economically backward people in particular.

5. CONSTITUTION:

The Trust shall be managed by the Board of Trustees.

1. **Mrs. I.JOY LEENA** shall be the Managing Trustee and he/she shall be entitled to continue as such during her lifetime. He/she has power to appoint his/ her successor in his/her place.
2. Other Trustees will act as Trustee and hold office for lifetime.
3. The Trustees will be entitled to reasonable honorarium for their services to the Trust.
4. The number of the Trustees shall not exceed TEN at any time.
5. In the case of death, resignation etc., of the Trustees, the Managing Trustee has the power to appoint any person in his/her place as Trustee.
6. The Managing Trustee has the power to appoint any other person as Trustee subject to the ceiling at any time as he / she wishes.
7. The Managing Trustee has power to appoint any person as Managing Trustee in his/her place during his/her lifetime. If no person appointed, one of children of the founder will become the Managing Trustee.



8. The Managing Trustee shall have the following powers:-
- i) To draw, make, accept, endorse, discount, negotiate, execute and encash cheques and bills of exchange and other negotiable instruments.
  - ii) To institute, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitration or abandon any legal proceedings by the Trustees against the officers or employees, concerning the affairs of the Trust, and to sign and verify vakalat claims, statements, affidavits, and other proceedings before all courts and government authorities both central and state.
  - iii) To appoint from time to time and any time to suspend, dismiss, remove or discharge any persons under her control including clerks, accountants and other employees.
  - iv) To delegate to another Trustee such works which have to be done by him/her.
  - v) To have control over the activities and assets of the Trust.

6. MANAGEMENT:


1. Subject to the provision herein, the Board of Trustees shall be entitled to exercise all such powers and do all such acts and things as are necessary to carry out the above mentioned objects.
2. The Board of Trustees shall meet at least once a year for approving the statement of accounts.
3. The Board of Trustees shall act as men of ordinary prudence with care and interest in discharging duties diligently and faithfully for the greatest advantage to achieve the objectives of the Trust.
4. They should not act in deterioration to the name and assets of the Trust. If any loss occurs because of the dishonest and carelessness of the Trustees, then he/she should be personally liable for such loss or losses.
5. If a Trustee is proved by appropriate evidence as dishonest and or his/her activities are proved to be against the interest of the Trust,



- then the Managing Trustee may serve notice of termination on his/her after calling for his/her explanation.
6. The Board shall be entitled to make and prescribe from time to time any rules and bye-laws and regulations for carrying the objectives of the Trust and also modify or amend such by-laws and rules and regulations within the frame work of the Trust.
  7. The Board of Trustees have power to start, establish branches any where in India and the branch has to function as per the rules and regulations as framed by the Board of Trustees from time to time.

7. MEETING OF THE BOARD: -

1. In addition to the annual meeting, the Board may meet from time to time as and when required.
2. The meeting shall be presided over by the Managing Trustee.
3. The Board shall transact any business that may be specified in the Agenda or otherwise agreed to by the Board members.
4. One half of the Board members or two members whichever is higher shall constitute the quorum.
5. All decisions shall be carried out by the majority decision of the Board, but in the events of equality of votes, the chairman presiding over the meeting shall have a casting vote.
6. Any resolution in writing signed by all the Trustees shall be binding on the Board as through it has been passed at a meeting of the Board of Trustees.
7. The meeting of the Board shall be convened after giving at least a week notice unless those who are entitled to receive notice agree to accept a shorter notice.
8. The Managing Trustee may invite others interested in the work of the Trust to attend the meetings of the Board but they shall not be entitled to vote there at.
9. All decisions shall be carried out by the majority decision of the Board.



8. BANK ACCOUNT: -

The Managing Trustee shall operate bank account individually or jointly with any one of the Trustees or as may be decided by the Board of Trustees. The account shall be in the name of the Trust.

9. INVESTMENT OF THE TRUST FUNDS: -

The Board shall have power to invest the corpus or the income from the trust fund at their discretion in accordance with the provisions of section 13(1) (d) read with section 11(5) of the Income Tax Act, 1961.

The Board shall also determine from time to time the amount it shall spend on the various aspects of the objects of the Trust.

10. ACCOUNTS AND AUDIT: -

The financial year of the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March.

The Accounts of the Trust shall be maintained regularly and annually audited by a chartered accountant appointed by the Board of Trustees and the audited statement of account shall be placed before the Board for its approval within six months from the close of the financial Year.


The Trust shall apply for registration with the income tax commissioner as a public Non-profitable social service and charitable body.

11. AMENDMENTS: -

This Trust shall be Irrevocable.

If any alteration or amendment were necessary the same shall be effected through supplementary deed/deeds with the previous approval of the commissioner of Income Tax and it shall be read together with this main deed.






12. DISSOLUTION: -



AND WHEREAS it was further more provided in the said Deed of the Trust that any alteration and amendment can be made whenever it is necessary.



This Supplementary Deed is executed on this 12<sup>th</sup> Day of September 2017 by the Author and Founder Trustee Mr.P.Isaac Livingstone, S/o Mr. D. Paul Devaraj, residing at No. 16, 7th Main Road, Thiruvalluvar Nagar, Chennai - 600 118.

WHEREAS THE TRUST, by an instrument of declaration of Trust (hereinafter referred to as the said instrument) registered as Document No.34 of 2017 of Book IV containing 18 Sheets in the Office of the Sub-Registrar, Madhavaram on 10.03.2017 and by an instrument of declaration of Trust registered as Document No.59 of 2017 of Book IV Containing 9 sheets in the office of the Sub-Register, Madhavaram on 19.04.2017 have granted, transferred and assumed the Trust property unto and to hold the same in Trust for the objects there under created.




AND WHEREAS it was further more provided in the said Deed of the Trust that any alteration and amendment can be made whenever it is necessary.

3. Clause 3.(XX) in page no 6 is amended by deleting the word 'loans' to read as follows: To establish and maintain and endowments fund for providing scholarship, books and reading materials etc., to the students from weaker sections of the society.

The initial amount of Rs.1000 (Rupees One thousand only) is still continuing as the corpus fund of the said Trust. The Trust has no movable and immovable assets except the corpus fund.



It is further declared that this instrument should be regarded as having always contained these presents as part and parcel of the main Deed.


